 2. ALL ENTRIES ARE ACCEPTED ON A "FIRST COME, FIRST SERVE" BASIS.
 3. SWINE ENTRIES WILL BE PENNED TWO (2) PER PEN. NO EXCEPTIONS! TO ENSURE THAT YOU RECEIVE A PEN, WE SUGGEST YOU ARRIVE EARLY. ONCE THE PENS ARE FULL, EXHIBITORS WILL BE ALLOWED TO WORK THEIR ANIMALS FROM THEIR TRAILER. EXHIBITOR IS COMPLETELY AND TOTALLY RESPONSIBLE FOR MOVING THE ANIMALS FROM THE TRAILERS TO THE SHOW RING.
 4. FOR ENTRIES TO BE ACCEPTED, ENTRY FORM MUST BE FULLY COMPLETED AND THE FEES MUST BE PAID AT THE TIME THE ENTRY FORM IS SUBMITTED TO THE TOOMBS COUNTY FFA ALUMNI. ENTRY FORMS WITH MISSING OR INCOMPLETE INFORMATION WILL BE RETURNED TO THE EXHIBITOR FOR COMPLETION BEFORE THE ENTRY WILL BE ACCEPTED IN THIS SHOW.
 5. SPONSORS RESERVE THE RIGHT TO CLOSE THE REGISTRATION PERIOD PRIOR TO THE DEADLINE IF NECESSARY.
 6. ALL ANIMALS MUST HAVE VALID HEALTH PAPERS AT CHECK-IN.
 7. ALL ANIMALS REGISTERED IN THE PURE BRED CLASSES MUST PRESENT REGISTRATION PAPERS AT CHECK-IN.
 8. FOR BREEDING GILTS, THERE MUST BE SEVEN (7) ENTRIES IN A BREED CLASS. IF THERE ARE FEWER THAN SEVEN (7) ENTRIES, THE ANIMALS WILL BE PLACED IN THE OTHER BREEDS CATEGORY.
 9. THERE WILL BE ABSOLUTELY NO SUBSTITUTIONS OF ANIMALS AFTER THE DEADLINE (SEPTEMBER 30, 2009). EXHIBITORS MUST SHOW THE ANIMAL(S) THAT HAVE BEEN REGISTERED AS OF SEPTEMBER 30, 2009.
 10. SPACE WILL BE AVAILABLE FOR MINIMAL WASHING AND GROOMING.
 11. THERE WILL BE NO CLIPPING OF ANIMALS AT THE SHOW.
