Rules, Regulations and Information

- RCC is open to Pre-Club, 4-H, and FFA members in the counties of: Banks, Elbert, Franklin, Habersham, Hall, Hart, Jackson, Lumpkin, Madison, Rabun, Stephens, Towns, Union, and White.
- All goats will be shown by weight.
- Each exhibitor/owner must assume all liability in case of death or injury to his/her animal and any injury or death incurred by his/her animal.
- Each goat must be accompanied by a valid set of Health Papers to be presented prior to unloading.
- Each goat must have an ear tag, preferably a state market show ear tag.
- Limit of three entries per exhibitor. Limit of 125 goats for the show. First received, first entered basis.
- There is a \$20 entry fee per head and a \$5 entry fee for showmanship. No fee for Pee Wee showmanship.
- All entry forms must be complete including signatures. Use separate form for each exhibitor. Make checks payable to EJ FFA Alumni.
- No refunds will be given on pre-registration. Checks and entry forms over the 125 head limit will be returned to exhibitor.
- Market class and showmanship pay back will be determined by sponsorship money available.
- Shavings for bedding will be provided in the livestock barn.
- Owners are responsible for the care and clean-up of his/her animal.
