Dear Mr. John Hagin,



Permission to use the roads, and access the properties shall be for March 20, 2014 only. This letter of agreement does not serve as an instrument granting an easement, right of way, or any other estate or interest in the land, but merely grants limited permission for temporary access as aforesaid, and such permission is terminable and revocable.

By executing this letter in the space provided below, Marion County High School Students and other area High School Students competing in the FFA Field Day and its employees, agents, students, or contractors agree to indemnify and hold the owner of the property, Timberlands II LLC, and Forest Resource Consultants, Inc. (CatchMark Timber Trust's field manager) harmless from any and all damages to person or property and all other losses, liabilities and expenses resulting from the actions of you, your employees, agents, students, or contractors while on the property.

In addition, by executing this letter, Marion County High School Students and other area High School Students competing in the FFA Field Day and its employees, agents, students, or contractors agree to leave the roads in a condition equal or better than its current condition and consistent with published Best Management Practices for the State of Georgia when Field Day activities have been completed.
