1. Any exhibitor from Georgia that has not completed 12th grade is eligible to show. Exhibitors must be in school and be a valid 4-H or FFA member.
2. All swine must have a current official health certificate which is to be presented prior to unloading.
3. Registered gilts must be born in February, March, or April 2017. Original registration papers for registered gilts must be in the exhibitor's name and presented at check-in.
4. Ear notches are required for registered gilts. Ear tags are required for commercial gilts and market hogs. The ear tag number must match the number on the entry form.
5. Registered gilt classes will depend on the number of breeds entered. Breed shows must have at least 10 entries to make a breed show. Breeds with less than 10 entries will be placed in either Terminal or Maternal Other Breeds.
6. Commercial gilts will be divided into classes according to weight.
7. Market hogs will be divided into classes according to weight.
8. Students must show their own hog in showmanship and in class. Any discrepancies will be handled by the show committee.
9. Check-in/weigh-in will begin at 9:00 AM Saturday, October, 7th. Showmanship will begin at 11:00 followed by registered gilts, commercial gilts, and market hogs.
10. Concessions will be available on Saturday, provided by the Statesboro High School FFA.
11. Each exhibitor/owner assumes all liability in case of death or injury to his/her animal and any injury or death incurred by his/her animal.
12. There is no maximum number of entries per exhibitor; however, exhibitors must show their own animals. If a student cannot attend, do not bring their animal.
13. Late entries will be accepted up to arrival, a \$10 late fee will be applied to each entry.
14. All entry forms must be complete with signatures; use separate sheets for each exhibitor.

17. There will be no refunds on entry registrations.
18. All show premiums will be paid in cash following the class.
19. Due to the limited space, exhibitors may have to share pens. Please indicate who you will share with on the entry form if you have a preference. Bring your own dividers.
20. Penning is limited and will be awarded on a first-come, first-serve basis. Bedding will be provided in pens. Be prepared to show off trailers after pens are full.
21. No animals may load out until the conclusion of the breeding gilt show.
22. No tack pens will be assigned; please put show items on a rack out of the aisle.

24. This is a jackpot show; all prize money will be paid out after show expenses. Prize money will be determined by the number of entries.
25. The show committee's decisions will be final.
26. All other state rules apply.
