## RULES OF SHOWS

### General

- The Show Committee has final decision making privileges over all show rules.
- Unless permission by the show committee is given, exhibitors must show his/her animals in all classes.
- The show is open to any current Georgia 4-H or FFA exhibitor.
- Animals must have ear tags in place and tag number must correspond with number on entry form; state issued 4-H or FFA ear tag is strongly preferred. Entries that do not have correct corresponding tag number will be disqualified and no refunds will be given. No animal substitutions after entry deadline.
- An official Certificate of Veterinary Inspection (Health Certificate) with the individual animal identification number is required to show.
- An exhibitor can show up to four lambs and/or four goats.
- Weight will determine market classes; there is no weight requirement.
- There will be no re-weighing once the animal has left the scale area.
- Shearing and/or clipping must be done outside of barn, weather permitting.
- As space is limited, please pen with your county.
- The owner is responsible for the care and cleanup of his/her own animal(s).
- Shavings for bedding purposes are in the barn.
- For showmanship, exhibitors will be classified based on grade level as of September 1, 2018; Showmanship Show will be divided based on grade level.
- There will be no Pee-Wee or novice classes.
- **All Georgia 4-H and FFA State Livestock Show Rules and Regulations will be followed.**

### Lamb Show

- Entries must be wether and/or ewe lambs (no rams will be allowed).
- All lamb entries must have their tails docked.
- Exhibitors are encouraged to show shorn slick lambs.
- Have lambs freshly sheared (no more than two weeks growth).
- The show committee reserves the right to mouth lambs should there be a question of age.

### Goat Show

- Entries must be wethers and/or does (no bucks will be allowed).
- Goats must have milk teeth.
- There is no rule on bracing.

The barn will be open on Friday, August 3, 2018; however, official check-in starts at 8:00 a.m. on Saturday, August 4, 2018 with the Lamb Show beginning at 9:30 a.m. The Goat Show will begin approximately 15 minutes after the conclusion of the Lamb Show.

A veterinarian with the State Department of Agriculture will inspect for Club Lamb Fungus and Sore Mouth before weighing. Current health papers must be available upon request.

## Entry and Premiums

- Entry fee is \$20.00 per lamb and/or goat .
- Completed entry form with payment must be postmarked or hand delivered to Gordon County Extension/4-H no later than Friday, July 20, 2018. Any entry postmarked after July 20th will be returned; no exceptions.
- Checks should be made payable to Gordon County 4-H.
- Premiums earned during the show will be paid by check and mailed during the week following the show date.

**Please keep in mind that entry fees are non-refundable; no exceptions.**
