General Award Guidelines

I. OVERVIEW

The National FFA Week Observance Award recognizes those chapters who have successfully and productively utilized FFA week in their Program of Activities.

II. PURPOSE

The National FFA Week Observance Award is designed to encourage chapters to take advantage of the promotional, educational and community development value of National FFA Week.

III. ELIGIBILITY

Any chapter in the state may apply. Only area winning applications are considered for state level awards.

IV. RULES

- 1. Applications are to be turned into the region office by March 10.
- 2. Applications should contain material from the FFA week that was celebrated during the same school year as the application is submitted. i.e. pictures from two years previous should not be in a current application.
- 3. Scoring will be based on the rubric shown below.
- 4. The State FFA Executive Committee and their appointees are in charge of this event.

V. APPLICATION FORMAT

- A. Cover page should contain:
 - Chapter name
 - 2. School name and address
 - 3. Advisor's name(s)
 - 4. Number of members in the chapter
 - 5. Number of students enrolled in agricultural education

B. Report should contain:

- 1. Cover page (as outlined above)
- 2. A maximum of four (8 ½ x 11") typewritten pages (doubled spaced with character font of 10-12 per inch) describing the activities, goals, plan of action and results of events engaged in by the chapter that highlight growing leaders, strengthening agriculture, and building communities in observance of National FFA Week. All type should be double spaced using font no smaller than 10 and no larger than 12.
- 3. Ten pictures (size and color optional) with a maximum of 25 words describing each picture. Five out of the ten pictures must showcase activities that highlight building communities, strengthening agriculture, or growing leaders.
- 4. A copy (1) of the local newspaper/chapter newsletter/school newspaper for National FFA Week.
- 5. A copy (1) of a social media posting (school website, Instagram, Facebook, etc.) for National FFA Week.
- 6. A maximum of two pages of supplemental information (i.e., proclamations, printed radio announcements, picture collages, etc.) should be included.

VI. SCORING

- 1. The top two in each area will be chosen and forwarded for state competition.
- 2. The judges for state competition will be selected by the State FFA Executive Secretary.
- 3. Judges will evaluate the completeness of each application using the scoring rubric below.
- 4. Special emphasis will be placed on chapter publicity to the community, recruitment of new members, events held in the school, and educational efforts to inform others about the FFA.

VII. TIE BREAKERS

Ties will be broken by the judges selected.

VIII. AWARDS

Awards shall be determined each year by the Board of Trustees of the Georgia FFA Foundation. The event is made possible through the Georgia FFA Foundation as a special project of an industry sponsor or from the Foundation General Fund. Minimum awards will recognize the top chapter in each area and the state winner.
